This report is required by federal law and contains policy statements, definitions of crimes, resources and annual crime statistics for the university. It also provides an overview of reporting options and how to report a crime. The website PDF and printed form contain information regarding campus security and personal safety including topics such as crime prevention, disciplinary procedures, bystander intervention, Campus Security Authority information, training opportunities and other matters of importance related to security and safety on our campuses. The reports also contain information about crime statistics for four previous calendar years concerning reported crimes that occurred on or immediately adjacent to the campuses. Since the Klamath Falls campus has on-campus housing, there is a separate fire safety section of the report with stats on recorded fires and sprinkler system types for each resident building. There is also valuable information pertaining to fire safety and what to do in case of a fire in a resident building.
